

#### **Out of State Extension**

Connecticut residents with vehicles located out of state at the time of their scheduled test date and 30 days after that may apply for a time extension. For more information on the required documentation needed and where to submit requests for approval, please click here.

#### **Reciprocity Testing**

You may be eligible to receive a reciprocal test from one of the following jurisdictions. Vehicles registered in Connecticut may be tested in one of these jurisdictions and comply with Connecticut's testing requirements. If your vehicle is eligible to receive a comparable emissions test in one of the following jurisdictions, you may apply for an extension equivalent to the two (2) year compliance your vehicle would receive in Connecticut. However, some of these jurisdictions may **NOT** be able to accommodate your vehicle's testing requirements, and in some cases, emissions testing is restricted to specific counties or regions. For further eligibility information, please be sure to check with the applicable jurisdiction before attempting an emissions test.

In general, the most common test is the <u>On-Board Diagnostic (OBD) Test</u>; all the jurisdictions listed here perform this test, however, there may be restrictions on model year and the Gross Vehicle Weight Rating (GVWR). The following chart designates the required inspection procedures for your Connecticut registered vehicle based on model year, GVWR and fuel type; click on the links for more information on the specific test:

- 1) A written request with vehicle owner contact information; including name, out of state address and telephone number.
- 2) An **Out of State Vehicle Identification Number** (VIN) Verification Form (<u>AE-81</u>), completed and signed by an out of state authority (military personnel, local or state police, or your local motor vehicle administrator/DMV).
- 3) For **out of state active military** personnel, please include a copy of current military orders.
- 4) An **out of state student** must also provide enrollment acknowledgment on school, college, or university letterhead.
- 5) If you are applying for full two (2) year compliance (Reciprocal testing), an official Vehicle Inspection Report (VIR) from an approved jurisdiction, the vehicle must have an overall **'Pass'** status. If your vehicle failed, it must be repaired and retested.





6) Please note that the Vehicle Identification Number Verification Form (AE-81) is **NOT** required for reciprocal testing submittals.
